

# PRIVACY POLICY

## INTRODUCTION

This is the privacy policy of Global Carbon Check, an association incorporated in Gujarat, India. It applies to all personal information collected by Global Carbon Check, including through their website at <https://www.globalcarboncheck.com/>. Global Carbon Check recognizes the importance of privacy and takes the responsibility of collecting and using personal information seriously.

## COLLECTION OF INFORMATION
